The May meeting of the Capital Mineral Club was held on May 14th at the Salvation Army Building in Concord NH. Meeting began at 2:08. The speaker was Kevin Downey, who gave a talk on Colombian minerals. After the presentation there was a short break and the business meeting began at

3:40. Secretary's report approved, treasurer's report read and approved.

Old business - Charlie talked about the field trip list and said it was getting late and time to make some decisions. There will be a collecting opportunity and a cookout at Jon Herndon's place on June 19th. Jon will be providing the meat for grilling and some soda, and encourages others to bring anything else they would like. There is a possibility of going to Moat Mountain on the 18th. She also recommended reaching out to the homeschool community.


