Secretaries report was approved as published. Treasurers report was read and approved. Show flyers and a thank you card from the Salvation Army wrapped up the correspondence.



Capital Mineral Club Grant Program Position 2

The Capital mineral club's scholarship committee had a meeting on 12/10/06. The committee has lost one member, Eric Cadieux and has gained two new members Gordon Jackson & Don Dallaire. The committee now consists of Bob Whitmore, Robert Wilken, James S. Tovey, Gordon Jackson & Don Dallaire.

The committee's business at hand was to review the two candidate applications we received and to review / critique the club's candidate grant application (formerly scholarship application) and the grant guide-line documents.

The items at hand that were accomplished and agreed to by the full committee are: For the Grant application:

- Application submittal and interview dates
- Name change to grant from scholarship
- Adding a additional paragraph outlining the obligations of the grant winner
- Adding a reference to Article 2 of the Capital Mineral Club By laws

For the Grant Guide line:

- Name change to grant from scholarship
- Adding a explanation that the Grant Guide lines follow Article 2 of the Capital Mineral Club By laws

The main issue that inspired spirited discussion was the proposal from Bob Whitmore, Gordon Jackson, and Don Dallaire to change the candidate requirements from students pursuing a college degree to a wider group. Their proposal is to open the grant to everyone for, projects, training, research, (or what ever). I, James Tovey was strongly against this proposal. The candidate requirements are a issue that has been discussed and presented to the club membership during the past year and this major change would need to be approved by the club membership. Also based on the Clubs scholarship past history the club scholarship is an opportunity for a college student to get extra training to enhance their education. My reasons why the Grant should not be opened up to a wider group are:

- The grant is based on need. A full time student pursing a degree doesn't have a steady income. It is a counter action to ask a student to compete against another person or group that have a steady income.
- Requiring a student to be a degree candidate makes it clear as to the individual's focus. It's easier for the grant committee to keep the process clear of any special interests.
- Why not expand the Grant candidate criteria to individuals that are not full time College students? My opinion is, the need is not clear. One of the main historical purposes of the scholarship was to give a college student an opportunity to get additional specialized training. By not clearly defining the candidate criteria, opens a cloud of special interest group pressure. It also adds to the committee workload to cut thru the gray areas.
- Why not expand the Grant to various types of projects & individuals to increase the participation?
 Again, my opinion is, the need is not clear. How and by who and will the project be supervised? How will we establish any accountability?

In conclusion:

By keeping the grant process exclusive makes it easer to justify the financial expense from other club activities, future needs & expenses. Keeping the process clear and simple makes it easer to govern and implement. The grant application participation will be only as good as the committee members and the club membership promote and get the word out to the state colleges, Universities and their students.

This issue is a club membership decision, which should be voted on:

Keep the existing grant candidate requirements: Supported by James S. Tovey Remove the existing grant candidate requirements and allow all individuals with mineral/geology related projects to apply. Supported by Robert Whitmore, Gordon Jackson, Donald Dallaire

THE "FENCE RIDING" CAMP OF ONE QUESTIONS TO CONSIDER BEFORE VOTING

The camps have lined up in favor and against the expansion of the grant fund. When I first considered the issue I **thought** I was solidly in the pro camp. In principal, I still favor it, but there are (a.) practical issues and (b.) ones of fairness that must be addressed. The issue of fairness is perhaps central to the argument against expansion. The practical issues are ones that have to do with how to implement the expansion. There is nothing to say that these matters can't be resolved. The current pro camp may come up with an easy solution to any and all problems, but my main point, as a committee member, is that **before** the club votes either way, shouldn't we offer some concrete ways of implementing it and dealing with these important issues?

The principal:

The principal behind the expansion of the club grant funds is to benefit parties that heretofore have not been included: primary and secondary school teachers and perhaps even public school students with worthy projects. In my mind and probably in the minds of most, this is a very worthy objective and it does comply with the club's by-laws.

Practical issues and questions:

Shouldn't we know if the goal is achievable before we declare we are going to achieve it? If the committee has to get the word out to teachers and students, it will be a monumental task. How would we make the grant known to every school district in the state? It is likely that this would have to be done yearly. Can we turn this task over to the State Education Department as one committee member suggested? Will they handle it? If the Education Department is involved will we lose any autonomy? Are we prepared to deal with the response any way that it is done? Should we consider limiting the expansion to a more local scale (Concord Schools e.g.)?

The sense now, is that the same committee that is handling the college grants will easily accomplish all of this. Remember, we are all volunteers. How much work will this task entail? How long will it take for current and future committee members to burn out and say: "This is too much like work?" Another likely result might be that the program ends up managed in a slapdash fashion and with a lazy eye. The committee charged with the college grant program is already giving a significant chunk of volunteer time. Would it be logical to have a second and separate committee for this endeavour? The grant criteria and implementation would have to be quite different.

Fairness issue:

The sense now is that the monies to finance the expansion would all come from the same pot as the college grants. The "Against" argument is that you have two totally different groups of people with totally different criteria competing for the same funds. Not only would this be pitting one group against another, it would make the source of funding from one year to the next undependable for both groups. If the source of money is not reliable for BOTH groups, why would either want to bother to apply? Also, if the pie stays the same size, with more people vying for it, how small do the slices become before they are worthless? Are there alternative ways of resolving this? Would it make sense to budget funds separately for both types of grants? How much more money does the club want to or afford to expend?

I offer these questions for the clubs consideration and welcome any suggestions.
